Update: Subdivision Streets



Your Meadowbrook Park Board of Directors continues to explore solutions for our deteriorating subdivision street pavement.

Many residents have noticed the deterioration and worry about the condition harming our vehicles, as well as impacting the values of our homes.

In the summer of 2018, we reached out to the Flushing Township Supervisor to request a bid on the cost to repair the roads in Meadowbrook Park. We are advised that there is no governmental revenue available to replace pavement in residential subdivisions. To understand the issue, the builders put these roads in and, to repair the roads, the homeowners would be responsible for the costs. There were six (6) neighborhoods in Flushing Township that requested to be rated and, as of January, four of the six have been completed.

We are still waiting patiently and will share the information when we receive it.
